Northern Ireland GCE results in 2021

- AS/ A level grades awarded in a year unlike any other
- Grades determined by schools and colleges based on a range of evidence
- A flexible approach to take account of varied levels of disruption

Today, the Joint Council for Qualifications (JCQ) published the A and AS level results for Northern Ireland.

Due to the COVID-19 pandemic this year's examinations were cancelled by the Education Minister, in January 2021. Alternative awarding arrangements were rapidly put in place, as schools, colleges, awarding organisations, regulators and the wider education system worked collaboratively to ensure that students could progress onto the next stage of their journey, be it further education, employment, or training. Similar approaches of teacher assessed grades were also adopted in England and Wales.

Teachers worked extremely hard, using their professional judgement and a range of evidence to determine students' grades. This flexibility, at the core of the process, ensured that schools and colleges were able to reflect what students had been taught and account for the various levels of disruption they experienced.

To support schools and colleges, awarding organisations provided extensive guidance, training and external quality assurance, to ensure grades were determined appropriately.

As the means of determining grades in 2021 has been different to any other summer, it was anticipated that the overall distribution of grades would differ from that of a standard year.

The provisional figures released today, demonstrate the collaboration of schools, colleges, awarding organisations, regulators, and the wider education system to implement the Summer 2021 alternative awarding arrangements.

A level

At A level 15.8% of students achieved the top A* grade, a 2.3 percentage point increase from last year. The A* - A grade also increased by 7.5 percentage points to 50.8%. At grades A* - E there was a 0.4 percentage point decrease to 99.4%, compared to 99.8% last year.

Outcomes increased across grades A* to A this year for both males and females: by 7.0 percentage points for males, and 7.9 percentage points for females. The gap between genders, at the highest grades, is similar to previous years.

Entries for A levels in Northern Ireland are up by 3.8%, which is in line with the increase in the school-age population. This year Mathematics continues to be the most popular A level, accounting for just under 1 in 10 entries.

Participation in STEM subjects (Science, Technology, Engineering and Mathematics) saw a small increase of 0.7 percentage points on the previous year, accounting for 36.5% of overall entries. This was largely driven by an increase in entries for Chemistry (+5%), Biology (+5.6%), Physics (+20.4%) and Mathematics (+5.9%).

AS level

AS level entries saw a further decline of 12.8% in Northern Ireland. This can be mainly attributed to the decoupling of the AS by the English based awarding organisations.

Provisional AS outcomes increased at grade A by 7.1 percentage points, with a decrease in the A - E of 0.7 percentage points.

Summer 2021: Alternative approach to assessment and grading

Following the disruption of the COVID-19 pandemic, it was decided that exams would not go ahead as planned, across England, Wales and Northern Ireland. Students' grades were based on their school or college's professional assessment of the evidenced standard at which the student was performing in the content they have covered.

The approach allowed for a high degree of flexibility for schools and colleges to take account of the varying levels of disruption experienced by students.

All awarding organisations are answerable to the regulatory authorities Ofqual (England), Welsh Government (Wales) and CCEA Regulation (Northern Ireland) for examinations standards.
