1. Restricted release of results to centres only

Electronic result files and supporting documentation will be available to centres via awarding bodies' secure extranet sites or A2C, as follows:

Grade boundaries, results files and their contents are confidential to the head of centre, examinations office staff and senior members of teaching staff within the centre, the consortium or Multi Academy Trust.

Grade boundaries, results, or information derived from results and grade boundaries **must not** be divulged to or discussed with:

- other teachers;
- candidates or parents;
- educational institutions or local authorities;
- the media;
- any other persons.

Additionally, grade boundaries, results, or information derived from results and grade boundaries **must not** be divulged or discussed on social media, such as Facebook or X (formerly Twitter).

Where a centre does not comply with these requirements, an awarding body reserves the right not to issue results under embargo in future series.

Centres are reminded of the requirement to have an examination contingency plan which **must** include procedures in the event of the centre being unavailable on results day, owing to an unforeseen emergency. The plan **must** also consider the potential impact of a cyber attack.

2. Publication of results (release of results to candidates)

Results may be released to candidates as follows:

Grade boundaries and results **must not** be released until after 08:00 on the appropriate date for the publication of results. **Candidates must not receive results by email, post or otherwise prior to 08:00**.

Any breach of these requirements will be considered as malpractice by an awarding body.

Centres should remind candidates that results are issued on a provisional basis. They may be subject to amendment by an awarding body, for example through the published post-results services, prior to the issuing of certificates.

3. Additional restrictions on the release of results

Results data and grade boundaries **must not** be shared more widely until after the candidates have received their results.

Once candidates have received their results, centres **must not** release results data, including grade boundary information, to local authorities, or share more widely, until after 09.30 on the appropriate date for the publication of results.

Similarly, centres **must not** issue press releases or statements to the media under any circumstances until after 09.30 on the appropriate date for the publication of results.

Any breach of these requirements will be considered as malpractice by an awarding body.

4. Use of electronic result files

Awarding bodies do not provide paper copies of candidates' provisional results. Centres will need to use the electronic result files to prepare the information that is released to candidates.

Where candidates need to provide their provisional results to third parties, such as Sixth Form or FE colleges, we strongly recommend that the candidate statements of provisional results are printed on school letterheaded paper and/or stamped with the school name and logo.

The candidate's Unique Candidate Identifier (UCI) must be included on their statement of provisional results, as this will support enrolment and entry for future examinations with Sixth Form or FE colleges.

5. Sixth Form and FE colleges

Sixth Form and FE colleges will see students supplying centre-endorsed results for enrolment purposes, e.g. results printed on school letterheaded paper and/or stamped with the school name and logo.

There is no distinction between provisional results data generated from an awarding body's extranet site or via a centre's MIS package (which, in most cases, will list the results from all awarding bodies). The provisional results are subject to change.

Where there is doubt, Sixth Form and FE colleges should liaise with schools to establish the candidate's results or, alternatively, request from the candidate their certificates once issued. The certificate is the final record of a candidate's achievement(s).
