Northern Ireland A level results in 2025



- Summer 2025 outcomes are stable and comparable to those of 2024.
- 30.4% of students achieved A* A grades.
- STEM subjects continue to count for over one third of A level entries.
- Mathematics retains top position as the most common A level choice.

Today, the Joint Council for Qualifications (JCQ) has published the 2025 Northern Ireland provisional results for AS and A level.

The provisional figures show that 30.4% of students received a grade A or above, in line with Summer 2024 (30.3% in 2024).

A level

The total number of A level entries in Northern Ireland has remained stable with 32,275 entries this year.

8.7% of entries achieved the A* grade, compared to 8.2% in 2024. 30.4% of entries achieved grades A* - A, compared to 30.3% in 2024.

Overall, 98.7% of students in Northern Ireland achieved A* - E grades, compared to 98.5% in 2024.

Over one third (37.3%) of A level entries in Northern Ireland continue to be in STEM subjects (Science, Technology, Engineering and Mathematics). Mathematics remains the most popular A level subject, accounting for 1 in 10 entries.

AS level

This year, AS level entries are up from 41,180 in 2024 to 43,362 this year, an increase of 5.3%.

In provisional AS outcomes, 27.2% of students achieved grade A, compared to 26.7% in 2024. Overall, 96.7% achieved A - E grades, compared to 96.4% in 2024.

The regulatory authorities monitor the awarding organisations' standards. In addition, the awarding organisations themselves conduct a number of comparability studies to compare standards. Maintaining standards within and across all qualifications to ensure fairness to all candidates is the paramount concern of the awarding organisations.
