

## **Northern Ireland GCSE Results 2025**

- **Summer 2025 outcomes are stable and are similar to those of 2024.**
- **31.6% of students achieved grade A/7 and above (31.0% in 2024).**
- **83.5% of students achieved grade C/4 and above (82.7% in 2024).**

Today, the Joint Council for Qualifications (JCQ) has published the 2025 Northern Ireland provisional results for over 32,000 GCSE students.

### **GCSE**

The total number of GCSE entries in Northern Ireland have decreased by 1.1% from 175,555 in 2024 to 173,675 in 2025. This is in line with the school population decrease in Northern Ireland this year of 1.0%.

31.6% of students achieved grade A/7 and above in GCSE, compared to 31.0% in 2024. 83.5% received grades C/4 and above, an increase of 0.8 percentage points compared to 2024.

### **English Language & Mathematics**

In GCSE English Language, 25.1% of students achieved A/7 and above, compared to 24.7% in 2024. 84.0% of students were awarded grade C/4 and above, in comparison to 82.5% in 2024.

This year's figures for GCSE Mathematics show that 27.1% of students achieved A/7 grade and above, compared to 27.8% in 2024. 73.1% of students were awarded a grade C/4 or above, which is similar to the 73.0% in 2024.

### **Subject entries**

Overall, 41.4% of all GCSE entries are in STEM (Science, Technology, Engineering and Mathematics) subjects.

4. Results are presented in provisional form. Results become final when the 'review of results' period ends.

There is an open qualifications market in Northern Ireland, which means that schools and colleges can choose to offer GCSEs from awarding organisations other than CCEA, such as AQA, OCR, Pearson and WJEC. Qualifications delivered in schools must comply with the Department of Education requirements.
6. Types of GCSE Awards: AQA, OCR and Pearson offer qualifications in Northern Ireland awarded in a 9 - 1 grading scale. A small percentage of students in Northern Ireland (3.3%) will receive a 9 - 1 grade, with the vast majority (96.7%) of students continuing to take A\* - G graded GCSEs.
